Dear Volunteers,

The importance of your influence upon the governance of our Council, and also upon the governance of Girl Scouts of the U.S.A., stands out as we begin the new Girl Scout year. Coming up this month we'll be holding meetings of service unit-elected delegates in every region. In November our national delegates, who were elected at the last annual meeting, will head to Houston for the 2011 Girl Scouts National Convention.

GSHPA's membership associates and regional directors work with volunteers on operational issues continuously by answering questions, listening to ideas, and fine-tuning procedures in order to help you deliver Girl Scouting to girls as smoothly and effectively as possible.

On the other hand, elected delegates help shape council-wide and national strategies and policies. For example, at the upcoming GSHPA delegates meetings we will be asking delegates for strategic advice on implementing one of the priorities we established in our recent Strategic Learning process, specifically, the non-troop Girl Scout Pathways (series, events, camp, travel, and virtual) at the Junior age level.

We will also be discussing the three proposals coming up for vote at the national convention. These proposals concern local council program fees, the annual membership year, and the election cycle for national delegates. It's the Start of a New Troop Year...* Good Rule of Thumb #1:

Take the Time to Update Your Troop Bank Account's Signatories

If you are a troop leader for the 2011-2012 troop year and/or are responsible for an existing troop bank account, please make a special point to stop by a branch of your troop's bank and update your troop bank account signatories. Keep in mind that anyone listed on a troop's bank account as a signatory has the ability to both deposit and withdraw your troop funds from your account. Even if you are a returning troop leader working with the same troop bank account you did last year, this is always a good practice just to make sure that former volunteers are no longer listed as folks who may access your troop's funds. Get your troop year off to a great start by stopping by your troop's local bank and updating who can access your troop's account within the next couple of weeks.

involve volunteers from three or more service units and meet the following criteria*, volunteer-led events/activities may be eligible for council-wide promotion via the monthly volunteer enewsletter, listings on our website and even free use of a GSHPA-owned camp property:

* Volunteer-led Day Camps, Camporees and Encampments do not qualify.

- The intended purpose of the activity must align with at least one council priority listed within the current fiscal year's operating plan.
- The activity must fill a niche that is appealing to the intended audience located throughout the council.
- The activity must be open to all who meet the predefined and agreed upon qualifications.
- Volunteer vs. Girl Activities/Events:
- If the activity is a Volunteer Event, it must include a minimum of 5 trainings that will help participants directly enhance/improve the type and/or quality of the Girl Scout experience they currently directly offer for girls.
- 2. If the activity is a Girl Event, it must align with 1 of the 3 Girl Scout Leadership Experience outcomes that GSHPA has prioritized and agree to perform a pre- and posttest of participants.
- The activity must have a volunteer committee representing a minimum of 3 service units involved in the planning and implementation of the activity.
- Must provide an anticipated budget reflecting anticipated income and expenses and a zero balance at completion of the activity.
- The activity must not conflict with an already established council-wide program that targets the same audience.
- The activity must comply with all policies and procedures as outlined in Volunteer Essentials and the appropriate Safety Checkpoints.
- The participants in the activity must be registered members of Girl Scouts in the Heart of Pennsylvania either prior to or as a result of their participation.

GSHPA Spotlight

Girl Scouts Spring to Action to Help Flood Victims

"To help people at all times," is the third line of the Girl Scout Promise that we all pledged to uphold when we became Girl Scouts. There has not been a time in recent memory in which people in the communities throughout our 30-county service area have needed help more than in the past few weeks due to the storms and flooding that have affected so many people. And help is exactly what countless girls and troops across our council did.

Many counties throughout our council were devastated by high flood levels and record setting rainfall, which caused rivers, streams and creeks to overflow their banks and run into the streets. Thousands were displaced from their homes and in need of help. Our girls and volunteers sprang to action to do whatever they could, from holding clothing drives to handing out drinks and cleaning supplies, to helping set up emergency shelters for members of the community who were evacuated from their homes. Below are some examples of flood relief efforts organized by our girls and volunteers:

 Led by Junior Troop Leader Joann Risso, Service Unit 329 took the initiative to start a Flood Recovery Drive to help their local area as well as their neighboring town, Pine Grove, which was affected by the recent flooding. They have had an outpouring of donations and all the troops have gotten involved. The troops have all made cards and posters to include with the donations they have collected. (See photo below)



- Michelle Swoga, troop leader, helped to organize a clothing and supply drive in Luzerne County.
- Cathy Grossbauer, troop leader, helped to organize a clothing and supply drive in conjunction with Our Lady of Mt. Carmel in Pittston, the local Kmart, Scranton Mission, Kids Klothesline, and Boul's Trucking. They gathered enough supplies to fill an entire semi truck full

of clothes to donate to anyone who was in need. This site was covered on a WNEP newscast. Those supplies went to people in need in Pittston, West Pittston, Duryea, Nanticoke and Shickshinny.

- Saundra Colwell, troop leader, helped to organize local relief efforts in Pittston and West Pittston.
- Daisy troop 32518, Brownie troop 32795, and Junior troop 30823 in the Nanticoke area organized a supply drive for supplies for kids.
- Tunkhannock service unit also organized a supply drive for those people in Wyoming County in need.
- When Halifax Middle School was turned into an emergency shelter during the flooding from Tropical Storm Lee, Beth Leonard, Service Unit Manager for SU 191 coordinated all of the services for those who had been displaced.
- An older girl troop in Service Unit 624 went into the Williamsport area to help some of the elderly residents clean out their homes. They helped carry damaged belongings and debris from basements and clean up as much as they could.
- Service Unit 327 from Pine Grove, which was devastated by the recent flooding, jumped at the opportunity to help their community out this past weekend. The Service Unit, girls and volunteers alike, coordinated with Operation Hugs and Kisses to pass out water, bleach, and towels, to victims of the flooding, and all this week they will be helping the Pine Grove Wesleyan Church with organizing donated items to hand out.
- Several girls from troops in Service Unit 628 volunteered at a local church that was being used as a drop off center for much needed cleaning supplies and other necessary items. They helped sort items as they were brought in and helped people that were still a little in shock at their situation gather the things they needed to start the recovery process.
- Another troop in Service unit 628 went door to door and handed out cold water, juice boxes, fresh fruit, buckets, cleaning supplies and other much needed essentials in the flooded areas.
- Girls from Service Unit 322 in Luzerne County have been conducting a door-to-door food drive in neighborhoods not directly affected by the recent flooding in their area. The girls collected nearly \$5,000 in food and cleaning supplies, which were then delivered to the West Pittston Salvation Army to restock their food pantry and distribute to the flood victims. They packed a van to the roof. The girls plan to continue these collections. (See

We know there were many more efforts to help flood victims by girls and volunteers that were not reported back to us. For these and all the instances listed above, we say THANK YOU to all our girls and volunteers. By coming together to help members of your communities in their time of need, you have exemplified the spirit of Girl Scouting and showed that you are helpful and friendly, considerate and caring, and courageous and strong and are living by the Girl Scout Promise and Law!

Forever Green Updates

How do you decide that you love something enough to spend your life making it, growing it, or teaching others about it? Let's ask the experts. Beginning this November, Girl Scouts in grades 6-12 can participate in several live video chats with business owners, public speakers, and educators who have taken a Forever Green pledge of their own.

The first video chat, scheduled for November 9, 2011 from 7 - 8 pm is with Alyssa Fine, PA 2011 Honey Queen and Emily Bruckart, Honey Princess. Both women are college seniors at Penn State and Shippensburg Universities; they travel throughout the state speaking on behalf of the beekeeping industry. Ms. Fine and Ms. Bruckart will each share her perspective on what motivates them to advocate for honeybees as well as some ways that environmental concerns impact honey production.

A video chat is a real-time, online discussion that features a host, speaker or speakers, and participants who need a computer (Mac or PC) with internet access and speakers to see and hear presentations. GSHPA Recycles: Every Wrapper Counts!



Beginning today, GSHPA troops can "Outsmart Waste" by collecting individual candy wrappers, large candy bags, and multi-pack candy wrapping for a council-wide recycling effort with Terracycle. Terracycle is a company that collects items we normally throw in the trash and finds ways to turn them into new products (e.g., candy wrappers and chip bags become pencil cases, purses, and backpacks!) Every wrapper counts! Start saving crinkly plastic wrappers from fall product sales and Halloween candy - just the wrappers – no paper inserts or candy, please! Put them in a (sealed) bag and bring them to a drop-off site in your region by Tuesday, November 15, 2011 also known as America Recycles Day. How many pounds of waste can we keep out of landfills? Remember, every wrapper counts, but don't eat any more candy than you normally do! Collect your friends' candy wrappers instead. Collections results will be announced in December 2012.

Accounts are Now Available for Troops and SUs to Make Tax-exempt Purchases

This is just a reminder that as you begin to make purchases for your troops or Service Units (SUs) as we start up our new troop year, GSHPA now offers special accounts which will allow you to buy items for your troops or SUs from our online council store without worrying about sales tax!

The tax-exempt accounts have already been set up for you. To access these accounts, please follow the steps below:

Logging into your tax exempt Troop or SU account for the first time

1. Please remember that your Troop/SU account is the one

GSHPA has created for your Troop or SU, not one that you may have already created yourself.

- 2. You can login to your new account by visiting GSHPA's online store homepage: <u>http://shop.gshpa.org/store/</u>
- Near the top, and on the right side of the store homepage under "My Account" enter the following information:
 - i. Troop/SU account username (the letters TR or SU followed by your 5-digit troopnumber or 3-digit SU number).
 - ii. Your password: GSHPA (this is case sensitive; all caps and no spaces). Once you have logged in, you will be able to personalize the password.

Camp Work Party Weekends Set for October

How would you like to bring your troop out for a free weekend of camping? All you'll have to do is join in the fun and get your hands a little dirty at one of our GSHPA Camp Work Parties!

Troops, adults and friends of Girl Scouting are encouraged to join GSHPA staff as we prepare our camps for the upcoming winter season. Participants will help with several end-of-year camp maintenance duties including, putting away seasonal equipment, cleaning up storm debris, putting away mattresses, and beds, and breaking down and storing tents. If weather and time permit, there may be some staining and/or painting, and also some trail clean up. Jobs will be assigned by committees and/or rangers and will be age-level appropriate.

The Camp Work Parties are set for the weekend of Oct. 15-17 at Camp Archbald and Oct. 21-23 at the following locations:

Saturday.

- Rules for Troop participation are as follows:
- Troop leaders must have all required camp and first aid certified adults with them
- Leaders are responsible for supervision of the girls; staying on task and in their assigned areas
- On departure, troops must check out with Site Hosts or Rangers and leave the unit they used cleaned and ready for the next group.

 - Sunday, September 11th, the weather matched the mood in Monroe County, gray and somber. There were many events held throughout the county to mark the tenth anniversary of the 9/11. One such event was the Healing and Remembrance Event at the United Way Memorial Garden in Tannersville. State Reps. Mario Scavello and Rosemary Brown along with Monroe County Commissioner, Theresa Merli spoke during the program. They were joined by firefighters, emergency responders and Girl Scouts from each of the five Service Units in Monroe County.

As an added bonus to the day's activities, Girl Scouts will help tag Monarch butterflies. The butterflies are tagged to learn about the fall migration patterns and population of the Monarch butterflies east of the Rocky Mountains.
 - Three Girl Scouts from Service Unit 226-Spring Valley earned the highest award a Cadette can earn: the Silver Award. They chose the organization Love Letters: Random Cards of Kindness Inc. as their project. The girls hosted an event to make cards for children (up to 18 years old) who are battling a life threatening illness. The
